AGREEMENT

between the National Youth Council of Namibia

and the Association of Non-Governmental Organizations National Youth Council of Russia

The National Youth Council of Namibia represented by Mr. Mandela Kapere, Executive Chairperson, acting under the Charter on the one side, and the National Youth Council of Russia, represented by Mr. Grigory Petushkov, the Chairperson, acting under the Charter, on the other side,

based on the Agreement between the Government of the Russian Federation and the Government of the Republic of Namibia on cooperation in the field of education from 2010,

believe that the development of cooperation between youth organizations of our countries is an important tool of enhancing mutual understanding and friendship between the two nations,

have entered this Agreement into force as follows:

ARTICLE 1: SCOPE OF THE AGREEMENT

Combining information, organizational and other resources, the Parties, in accordance with the laws of both countries develop their cooperation in the following areas:

- capacity building of youth organizations of Russia and Namibia;
- promoting the participation of youth in decision-making processes that affect them and the development of youth volunteer programs between the two countries;
- development and the implementation of bilateral projects in the field of youth policy between the two countries;
- development of international youth cooperation among youth associations, student, and post-graduate students, members of youth consultative structures, youth entrepreneurs, young journalists, young scientists, etc.;

- expansion of humanitarian, business and cultural relations among young people, deepen cooperation in the field of scientific and technical creativity of youth;
- promoting the exchange programs between experts including practically oriented exchange of views and experience of youth workers within the organization of bilateral internships;
- encouraging the participation of the youth leaders, youth workers in the international youth seminars, symposia, conferences held in their countries;
- contributing to strengthen the cooperation at the international youth platforms;
- exchanging of publications and information on the development of youth policy and youth work, popularization among youth the cultural and traditions of the two countries;
- developing proposals for the development of youth tourism and directions of bilateral and multilateral youth cooperation.

ARTICLE 2: ORGANISATION AND OPERATION

For the organization and operation of joint projects the Parties:

- Develop and approve the annual joint action plans;
- Create the necessary working bodies (organizing committee, coordinating advisory councils and working groups), the composition and management of which is formed and approved by the agreement of the Parties;

The Agreement shall not limit the right of the Parties to cooperate with and join other associations.

ARTICLE 3: COMMENCEMENT, TERMINATION & RENEWAL

The Agreement shall enter into force upon signature by the Parties and shall remain valid until such time when one Party gives notice of its intention to terminate it.

Parties shall convene every two years to review and improve on the provisions of the Agreement.

Signed in Windhoek on the «_17_» _November__ 2016 in two copies, each in Russian and English. All texts being equally authentic.

In case of discrepancies, preference is given to the English text.
